BANK ACCOUNT

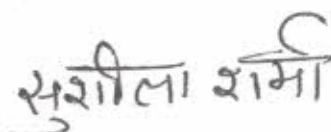

a) The management and control of the trust and the trust properties shall vest in the Board of Trustees.

b) The tenure of the members of the Board of Trustees shall be life long . However, refer to point (c).

c) Termination of Office of the Trustees:

Trustee shall cease to hold office:

- i) If he/ she dies,
- ii) If he/ she resigns,
- iii) If he/ she is adjudged insolvent or found guilty of an offense involving moral turpitude.
- iv) If he/ she is found to have acted against the interest of the Trust.
- v) If any trustee do not perform his/ her duty diligently / honestly then the settlor/ founder/ chairperson can remove such trustee from the trust out rightly.
- vi) Upon expiry of the period up to which the Board of Trustees have nominated the trustee.

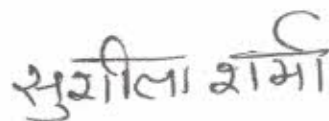

d) The Board of Trustees/ founder/ settlor may nominate and invite person/ persons to be the other trustees as they may deem fit and proper.

e) If in the opinion of the settlor/ founder/ chairperson, circumstances so require, the settlor/ founder/ chairperson may unanimously make any amendment in the rules, they may consider necessary for the better management and administration of the trust activities or for carrying out the objects of the trust.

f) Board of Trustees shall meet at least once during a calendar year and may meet more often when required. There shall be minimum of one such meeting during the span of one year. Quorum of the meeting shall be half members of the Board. No trustee shall absent himself/ herself in four consecutive meetings of the Board without seeking its permission. Trustees can also join the meeting via telecom or video conference. In special

g) The Board of Trustees shall have normal voting rights. In the event of equality of votes on any matter while carrying out a resolution, the chairperson/ founder shall have power for the 'Casting Vote'.
